**Current Recommendations of Major
Changes/Revisions to the Alabama
ESSA State Plan**

Title I, Part A

1. Removed all direct references to *Alabama Ascending*

Title I, Part A

2. Add/Strengthen language for:
 - a. All aspects of educating students with disabilities
 - b. All aspects of educating students in various at-risk categories and designations
 - c. The Arts
 - d. The health and well-being of all students

Title I, Part A

- e. Career Tech
- f. Creating opportunities for professional development and advancement through the National Board for Professional Teaching Standards and other programs/avenues

Title I, Part A

- g. Creating quality assessments through input from a Stakeholder Advisory Group and Technical Advisory Panel
- h. Reducing remediation rates for students graduating from high school and attending college
- i. Remove any barriers to learning facing students from military families

Title I, Part A (continued)

3. Refocus/Refine professional learning opportunities utilizing technology where possible while moving to more regional/local offerings that are aligned to identified needs

4. Base Reports of College- and Career-Ready Students on the Full Cohort and not the Graduate Cohort

5. Better explain Chronic Absences v. Truancy and focus on having students in school

6. Add language about hiring, growing, and retaining effective teachers and leaders, principally principals, i.e., mentoring of first-year teachers, math and science teacher scholarships, National Board for Professional Teaching Standards scholarships, SREB grant, other leader and teacher grants and initiatives.

7. Revise the threshold of a low graduation rate (67%) for schools being identified for support and improvement to 10 percentage points below the state average

Title II, Part A: Supporting Effective Instruction:

1. Added principals and other leaders
2. Provide online, face-to-face, job-embedded, and sustained professional learning opportunities, as well as pre-service training, and professional learning. Additionally focus on educator preparation/program evaluations. State Department of Education personnel and education stakeholder groups will identify needs for the above.
3. Discontinue the Annual MEGA Conference and refocus resources to move local and regional venues focused on more locally and regionally identified needs
