**SUBJECT:** 2019-2020 ALACTE Survey and the Alabama Teacher Mentor Program Survey Update

The Alabama State Department of Education (ALSDE), Office of Teaching and Leading, is soliciting your urgent assistance in ensuring that your staff provide stakeholder feedback for the 2019-2020 Survey for Employers of New Teachers and its companion survey, the 2019-2020 Survey for New Teachers. Both surveys were originally set to run from Wednesday, April 1, 2020, through Thursday, April 30, 2020; however, due to the COVID-19 shutdown, the dates were changed. The surveys were launched two weeks ahead of time on March 16, 2020. The surveys will remain open through June 1, 2020.

We recognize that staff are now working under difficult conditions, but their participation in completing these surveys should be **strongly** encouraged. The purpose of the surveys is to provide feedback for continuous improvement of Educator Preparation Providers (EPPs) in Alabama. Also, the annual ALACTE survey results are used to prepare the annual EPP Report Card. Results from the survey will be reported in aggregate form only. Teachers and employers will not be identified in the results. An Executive Summary of aggregated statewide results will be created and shared by the ALSDE. Last year, there was a good response rate for the surveys, and we hope for a better response rate this year.

Also, the Alabama Teacher Mentor Program (ATMP) is soliciting stakeholder feedback from participating mentors and mentees in the program. The titles of the ATMP surveys are 2019-2020 Alabama Teacher Mentor Post Survey and the 2019-2020 Mentee/Beginning Teacher Post Survey. The purpose of these surveys is to provide feedback for continuous improvement of the ATMP. Results from the surveys will be compared to the pre-survey data and reported in aggregate form only. Mentors and mentees will not be identified in the results. The survey links are attached for easy access.
