SUBJECT: 2020 Alabama School Transportation Association Conference

The 78th Annual Alabama School Transportation Association (ASTA) Conference will be held in Mobile, Alabama, June 8-12, 2020, at the Renaissance Riverview Plaza Hotel in Mobile, Alabama. The conference program will again offer an excellent selection of training sessions. Conference topics will include: "hands-on" topics like medication on buses, student behavior, bid law, mechanic classes, and more. A special part of the conference will be the trade show that will feature local, state, and national vendors. Alabama's school bus dealers will also provide information about their new buses and other products.

The Alabama State Department of Education (ALSDE) and local school systems in Alabama have supported this conference since its beginning. The conference has always provided excellent training for transportation supervisors and office personnel, shop personnel, and other key persons in our local transportation programs. Therefore, I strongly encourage your system's participation. A conference registration form and other conference information are included with this memorandum.
