1.00 Administrative Overview

1.1 Purpose and Background

Purpose:

The primary objective of this proposal is to bolster our capacity for effective capital planning by establishing a baseline of facility information. Our aim is to deliver comprehensive condition assessments of the facilities and schools listed in Appendix B, thereby facilitating a more informed prioritization of maintenance and capital improvement needs. Through these assessments, the Alabama State Department of Education (ALSDE) and Local Education Agency (LEA) will gain an enhanced ability to pinpoint urgent improvements, ensuring the creation and maintenance of safe and optimal learning environments for the students and educators of Alabama.

Background:

"The Alabama State Department of Education (ALSDE) has identified 21 diverse school districts facing a myriad of challenges. These challenges span from a deficiency in capacity to conduct comprehensive master planning for capital needs to the stark constraints imposed by limited financial resources. Within these districts, a pronounced absence of technical support for preventative maintenance, operations, and data collection further compounds the difficulties faced by educational institutions. As a consequence, creating and maintaining safe and conducive learning environments for students becomes a formidable task. This proposal aims to address these challenges head-on, to implement impactful solutions that will uplift the infrastructure and overall educational experience across these districts."

1.3 Proposal Evaluation

An Evaluation Team will review the proposals and make a recommendation. The criteria listed below will be used to evaluate the proposals for the purpose of ranking them in relative position based on how fully each proposal meets the requirements of this RFP.

Evaluation Criteria:

Vendor qualifications and experience	35 points
Budget Proposal	30 points
Detailed example of condition assessment to be provided	35 points

Best and Final Offers:

The ALSDE may either accept a vendor's initial proposal by award of a contract or enter into discussions with vendors whose proposals are deemed to be reasonably acceptable consideration for award. After discussions are concluded, a vendor may be allowed to submit a "Best and Final Offer" for consideration in a manner and method prescribed by the ALSDE. By submitting a proposal each vendor accepts and agrees to all conditions and requirements herein.

The ALSDE will make all decisions regarding evaluation of the proposal. The ALSDE reserves the right to judge and determine whether a request is compliant with and has satisfactorily met the requirements of the RFP. The ALSDE reserves the right to waive technical and other defects if, in its judgment, the interest of the ALSDE so requires. Any further information disclosed about the RFP during this process will be provided to all vendors in a manner and method prescribed by the ALSDE.

Rejection of Proposal:

ALSDE reserves the right to reject any or all proposals which are deemed to be non-responsive, late in submission, or unsatisfactory in any way. ALSDE shall have no obligation to award a contract for work, goods and/or services as a result of this RFP.

Confidentiality:

All information contained in the RFP is considered to be the exclusive property of the ALSDE. Recipients of this RFP are not to disclose any information contained within the RFP unless such information is publicly available. This RFP is provided for the sole purpose of allowing Vendors to respond to these specifications.

Selection Process:

The number of grants awarded depends on the number of proposals submitted and the quality of the proposed projects, funding availability and the best interests of the Agency.

The ALSDE will select the vendor or vendors that provide the most technically sound and cost-effective proposal that best fits the needs of the ALSDE. Final selection of the successful vendor or vendors will not be based solely on cost. The vendor product will be evaluated primarily on the scope of the activities linked to associated costs as detailed in the RFP. RFPs will be reviewed to ascertain that minimum requirements have been met. The ALSDE reserves the right to conduct discussions with potential vendors in order to clarify information contained in their proposals, but the ALSDE has no obligation to do so. The vendor will provide notice to the ALSDE any partnership with another firm to provide parts of the solution; however, the vendor must provide management of the partner and is responsible for all project performance. Any subcontractor or partner will be subject to the same vetting process as the vendor, and the vendor is responsible for ensuring that each subcontractor acknowledges and is contractually bound by the staffing plan and other commitments listed in this RFP.

Unless provided by law, nothing in this RFP shall be construed to create any legal obligation on the part of ALSDE or any respondents. ALSDE reserves the right, in its sole discretion, to amend, suspend, terminate, or reissue the RFP in whole or in part, at any stage. 1.4 Conditions and Terms

Contract Terms:

The contract resulting from this RFP may be renewable for four (4) additional years pending written agreement of the vendor(s) & ALSDE, dependent upon required state approvals, availability of funds, performance evaluations of the project, at the full discretion of the ALSDE. The contract will commence pending Legislative Review Committee approval and Governor's signature.

The vendor(s) shall be fully prepared to commence work after full execution of the contract by parties and the receipt of required governmental approvals.

Proposals should reference each element in the RFP by number on the cover of each copy and be arranged in the same sequence. All fees and costs are to be stated in United States currency. Vendors must reply to each element of the RFP.

School Facilities Condition Assessment

2.00 Scope

2.1 Scope of Vendor's Work and Responsibilities

Prospective vendors are required to submit, along with this proposal, a comprehensive timeline for the completion of assessments and examples of condition assessment reports. The selected vendor(s) will conduct thorough site visits and condition assessments for all facilities and schools outlined in Appendix B.

The condition assessment reports will be developed by architectural professionals through a meticulous process involving interviews with school maintenance staff, facility walk-throughs, and in-depth building system analysis. The reports will serve multiple objectives:

- Identification of basic site and building features as generally observed.
- Provision of a straightforward evaluation format outlining the current condition of the site and building features.
- Presentation of a visual facilities condition scale for each assessed facility/school, aiding in prioritizing maintenance and capital improvement needs.

These assessment reports will address each facility/school individually, highlighting outstanding conditions or concerns categorized by distinguishable facility areas, including but not limited to:

- Site/Grounds (Student/Pedestrian Canopies, Sidewalks and Lawn, Landscaping, and Drainage)
- Building Exterior (Windows, Roofing)

- Building Interior (Floor, Wall, and Ceiling Finishes; Door Frames & Hardware; Plumbing System; Mechanical, including HVAC; Lighting System; Emergency and Exit Lighting; Power Systems; Fire Alarm Systems; Toilet Facilities; Signage; Storage (cabinetry); Accessories)

It is imperative that condition assessment reports for each facility/school are provided on or before September 30, 2024. Additionally, all invoices for the work performed must be submitted on or before the same date.

2.2 Scope of Alabama State Department of Education's Work and Responsibilities

The Alabama State Department of Education (ALSDE) will furnish the selected vendor(s) with a comprehensive inventory of facilities/schools slated for assessment, encompassing precise addresses, designated points of contact, corresponding phone numbers, and email addresses for each school district. Concurrently, ALSDE will dispatch a Superintendent Memorandum to all district superintendents implicated in the award, apprising them of the forthcoming tasks and proposed timetable.

Furthermore, ALSDE will convene a webinar tailored for district leaders and the awarded vendors, serving as an inaugural platform to delineate the nature of the anticipated work. Ultimately, ALSDE is committed to aiding the awarded vendor(s) in mitigating any obstacles or challenges that may arise during the execution of the assigned tasks.

Section 3.00 General Requirements

3.1 Requirements of Proposal

The vendor must provide the following mandatory information. **Failure to provide this information may be cause for the proposal to be rejected.** Qualifications, experience, and cost will be evaluated for contract award. The proposal may be submitted under the same cover with Vendor Requirements and Cost Proposal in two distinct sections. E-Verify information is required to be submitted for all employees to include contractors of the vendors if necessary and applicable.

Part I

Signed Cover Letter:

The cover letter shall serve as the first page of the vendor's proposal. The vendor shall complete the cover letter and attach it to the proposal in response to the RFP. The cover letter must be signed by an official authorized to legally bind the vendor. It will state that the vendor is a legal entity that will meet the specifications. The cover letter must accompany the submitted proposal. The letter accompanying the proposal must have original signatures and must include contact numbers and e-mail addresses for the authorized official signing the letters.

Part II

Vendor Qualification and Experience:

Vendor shall provide satisfactory evidence of the vendor's capability to coordinate the types of activities and to provide the services described in the RFP in a timely manner. Special attention should be given to the discussion of qualifications. The discussion shall include a description of the vendor's background and relevant experience as related to the following qualifications and experience:

- Previous project experience and performance as the principal engineer on projects of similar size, type, and complexity.
- Each project team member to demonstrate knowledge, experience and competence of primary facility systems and structural components as well as extensive field experience in existing structures equal or greater size and scope in the last 5 years.
- Previous experience working on a State of Alabama Project and familiarity with the Division of Construction Management's procedures.
- The design team's location and availability to visit and monitor the project site.
- Have a licensed Professional Engineer who is currently registered to practice in the State of Alabama on staff.

The Applicants and any consultants shall hold current professional licenses and be registered in the State of Alabama.

Part III

The vendor shall provide a minimum of three (3) references that can support and validate training and/or projects and outcomes, including names or persons who may be contacted, position of person, addresses, and phone numbers where similar training and/or projects to that described in this RFP have been conducted.

Executive Summary:

An executive summary is required. This summary will condense and highlight the contents of the vendor's proposal.

Part IV

Cost Proposal:

Vendor shall include the fee structure and pricing for the facility condition assessments. The vendor shall submit a cost proposal in addition to other required information.

Flat rates for half and/or whole day site visits should be inclusive of travel and/or supplies and materials costs. Flat rates for consulting, observing, and/or professional services should stipulate the cost per hour and the proposed number of hours. Project costs must include all proposed necessary charges to be made by the grantee in accomplishing the objectives of the grant. All work and invoice submissions must be completed on or before September 30, 2024.

Subcontractor Disclosure:

If the execution of work to be performed requires the hiring of Subcontractors, **you must clearly state this in the bid proposal and provide qualification for such individuals.** Sub-Contractors must be identified and the services they will provide or work they will perform must be clearly defined. The ALSDE will not refuse a proposal based upon use of a Sub-Contractor; however, the ALSDE reserves the right to refuse the Sub-contractor you have selected. Contractor and associated personnel shall remain solely responsible for the performance of all work, including work that may be sub-contracted.

4.00 General Terms and Conditions

4.1 Governance

This RFP and its terms shall be governed and construed according to the laws of the State of Alabama. Any dispute arising out of this RFP shall be brought in the State of Alabama, with venue in Montgomery County, Alabama. Vendors agree to comply with all applicable federal and state laws and regulations.

4.2 Immigration

The proposal must contain a statement that the firm is aware of and in compliance with the requirements of the Beason-Hammon Alabama Taxpayer and Citizen Protection Act; a statement that the vendor is enrolled in the E-Verify as required by School Facilities 31-13-9 (b), Code of Alabama 1975, as amended:

BEASON-HAMMON ALABAMA TAXPAYER AND CITIZEN PROTECTION ACT

COMPLIANCE

The Beason-Hammon Alabama Taxpayer and Citizen Protection Act (31-13-1 et seq, Code of Alabama, 1975 as amended by Act 2012-491) regulates illegal immigration in the State of Alabama.
