**RE:** Assessment Testing Dates for 2024-2025

The dates for the 2024-2025 statewide assessment program have been finalized and are being provided for your convenience in building your school calendars and scheduling tests. Please note the following reminders:

1. In an effort to receive the students' reading scores back before school dismisses for the summer, we are requiring districts to test **all** Grade 2 and Grade 3 students on the *ACAP Summative* English Language Arts assessment during the **first four weeks of the testing window**.
2. *ACT WorkKeys* will remain as an optional assessment. Districts will have the option to administer *ACT WorkKeys* to all students in Grade 12 or administer only to selected Grade 12 students. A retest opportunity will be offered in the spring for those students who do not meet the benchmark in the fall.
