How will the LEA determine the most important educational needs as a result of COVID-19?

Opp City Schools will conduct a needs assessment to determine the most important educational needs. The needs assessment will assess the child as a whole extending beyond academics to other factors that impact educational needs such as mental and physical health issues, home and family conditions. Upon the return to school, regardless of the learning option, students will be assessed using a formative test to determine present level of learning. Previous test data will be used to determine if there is a level of regression in past performance. Kindergarten — 3rd grade students will participate in the iReady Reading and Math formative assessments. Grades 4th — 12th will utilize iReady, edmentum or Scantron Performance Series for formative assessments.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

Once learning gaps and deficiencies have been identified, each student will be provided a prescribed learning path to address the identified learning needs. Students identified will engage in supplemental activities that focus on the identified needs. This supplemental support will be in the practice of web-base learning paths, teacher led intervention or both in some cases.

What is the LEA's proposed timeline for providing services and assistance to students and staff?

Supplemental support for students K -3 were offered during July this summer. Services for students with special needs also began in June for secondary students. It is the district's desire to begin efforts to identify educational needs for students the first two weeks of school. Once learning gaps and present levels of performance are identified appropriate learning paths can be implemented. Optimistically this will be in a traditional setting so the teacher can be utilized to her potential. Virtual students will receive support through a teacher to the greatest extent possible.

How will the LEA use ESSER funds to promote remote learning?

The district proposes to equip instructional staff with the needed technology equipment to deliver the most optimal remote learning experience. Extending beyond the physical equipment, the district will purchase software that enhances video recording and lesson delivery. ESSER funds will also be utilized to create wifi access on school buses to accommodate those in need.

 - (7) that in the case of any project involving construction -
 - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
- (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
