RE: LEA Credit Recovery Plans

The Alabama State Department of Education (ALSDE), Instructional Services Section, is collecting the annual documentation of local education agencies (LEAs) participation in Credit Recovery. Regardless of an LEA's decision to offer Credit Recovery, all LEAs are required to complete the Annual Credit Recovery Collection Form no later than May 14, 2021.

LEAs offering Credit Recovery should review their current plans prior to submitting the Annual LEA Credit Recovery Form. LEA Credit Recovery contacts will be prompted to verify assurances are being met, provide information specific to the Credit Recovery Plan, and submit the current Credit Recovery Plan.

LEAs may visit the ALSDE Instructional Services Section website to access the Credit Recovery resources tab. Technical Assistance and Office Hours will be held to provide guidance and support for LEAs. A schedule of the virtual meetings is attached.
