RE: Fiscal Year (FY) 2024 Spring/Summer Language Essentials for Teachers of

Reading and Spelling (LETRS®) Stipend for Mastery

The Alabama State Department of Education (ALSDE) will provide a one-time stipend of \$1,000 to eligible candidates who have completed the LETRS® or LETRS® for Early Childhood (LETRS® EC) course **and** demonstrated mastery level on the Learning Platform coursework as evidenced by a score of 80% or greater on the posttest(s) for their course. The Alabama Reading Initiative (ARI) team has developed an <u>informational flyer</u> (attached) that can be sent to your employees to notify them of this opportunity. Each eligible candidate must submit his or her application by Friday, July 12, 2024, using the link <u>LETRS-Stipend for Mastery</u>, <u>Spring 2024</u>. The following criteria are used to determine candidate eligibility for the current stipend opportunity.

- Completed the LETRS® (Units 1-8) or LETRS® EC (Units 1-4) course. Course completion includes online coursework, offline coursework, bridge-to-practice activities, and live face-to-face/virtual trainings.
- Scored at **mastery level** on the learning platform coursework as evidenced by a score of 80% or greater on the **posttest(s)** for the course.
 - LETRS® Units 1-4 Posttest and Units 5-8 Posttest
 - LETRS® ECE: Units 1-4 Posttest
 - Participants wishing to retake a posttest will need to use the link <u>Spring posttest reset survey 2024</u> to request a posttest retake. The ALSDE will not be responsible for any fees associated with retakes of posttest(s). The deadline to submit the test retake form is Friday, June 21, 2024.
- Properly certified by the state of Alabama. This includes emergency-certified teachers.
- Employed (full-time, part-time, or contracted) educators of an Alabama public PreK-12 school, the ALSDE, or Institutions of Higher education (IHEs) including, but not limited to, PreK-12 teachers, building administrators, central office administrators or support, professors, assistant professors, paraprofessionals, instructional assistants, local reading specialists, regional literacy specialists, and ALSDE employees. Only PreK teachers who are **not** eligible for the Alabama Department of Early Childhood Educators (ADECE) stipend will be eligible for the one-time stipend provided by the ALSDE.

No stipend is available for the LETRS® for Administrators course, as there is no pre/post-assessment. However, administrators who have achieved mastery status in LETRS® or LETRS® EC are eligible for the stipend.

Although educators will receive a \$1,000 stipend, the local education agency (LEA), ALSDE or IHE will receive \$1,200 from ALSDE. The extra \$200 will help to assist in covering the employer benefit costs associated with the stipend. Please be aware that the stipend is considered income and, subsequently, is taxed as income. This \$1,000 stipend is not guaranteed from year-to-year and is being provided based on the state's *American Rescue Plan Act* (ARPA) (ESSER III) federal appropriation for this current FY 2024. These reimbursable funds to the district use the reference **LEA Code 4308-ESSER III, LETRS**. Upon completion of candidate notification and verification, the LEA will request reimbursement for all eligible candidates. Any remaining portion of the allocation after the stipend and benefit expenses are paid, should be used for high-quality instructional materials for that teacher's classroom. **Please be aware that there is extensive application verification, in addition to the time needed to process funds at the ALSDE and LEA levels.** We thank you in advance for your patience.

Course completion includes online coursework, offline coursework, Bridge-to-Practice activities, and face-toface/live-virtual training. * Scored at mastery level on the LETRS Platform coursework as evidenced by a score of 80% or greater on the posttest(s) for the course.

oLETRS® Units I-4 Posttest AND LETRS® Units 5-8 Posttest.

OR

oLETRS® ECE: Units I-4 Posttest * For applicants needing a retest, complete the <u>Test Retake Form</u>. The deadline to submit the posttest retake form is Friday, June 21, 2024.
