RE: Fiscal Year (FY) 2025 Elementary Reading and Math Assessments Schedule and Funding Information

The dates required by the *Alabama Literacy Act* (ALA) and the *Alabama Numeracy Act* (ANA) for the 2024-2025 Elementary Reading and Math Assessments involving kindergarten through fifth grade students have been finalized and are attached, including dates released in the [December 15, 2023 memorandum](#). The First Grade Readiness Assessment and the Kindergarten Entry Assessment are also included.

Early Years Assessments (EYA) and Math Screeners Funding:

The per-pupil allocation will be based on the previous fiscal year's average daily membership (ADM) and is contingent on meeting the requirements outlined below. Allocations calculated on FY 2024 ADM are attached. Local education agencies (LEAs) will be allocated \$6 per pupil for the following screeners:

- EYA Math Grades K-3 Fund Source 1262-Special Use Code 0043
- EYA Reading Grades K-3 Fund Source 1262-Special Use Code 0044
- Early Numeracy Screener Grades K-2 Fund Source 1232-Special Use Code 0041

Requirements for Funding:

1. Use the [linked form](#) to select your assessment choices for your district.
2. Spend funds only on items directly related to the screeners and assessments.
3. Set up an account and create class rosters with each vendor prior to the EYA-Beginning of Year (BOY) testing window.
4. Administer each screener or assessment according to the published guidelines and testing windows.
5. Complete data reporting agreements with vendors allowing direct data reporting to the Alabama State Department of Education.
6. Ensure that data reports and any additional reports are complete and submitted by deadlines.
7. Funds are set to be released in two installments with payments in January and April of 2025.
