PERFORMANCE GUIDELINES

For any **Growth Needed** responses, documentation of appropriate mentoring, professional learning, and/or training must be submitted. If more than two **Growth Needed** responses are provided **OR** if the LEA responds **NO** to question 10, there must be documented evidence showing that the necessary support was provided and the individual is aware of the areas in which growth is needed. Also, the individual will be required to complete another full year of full-time, teaching experience (with improvement in those areas) even if all other requirements are met. **Since there is a limit on the number of alternative certificates that can be held, the LEA and the individual should be aware of the individual's performance at all times.**

PERFORMANCE INDICATORS

Proficient- As a beginning teacher, the teacher is proficient in his/her understanding of the content.
Developing- As a beginning teacher, the teacher is adequately developing his/her understanding of the content.
