WHEREAS, *Alabama Administrative Code*, Rule 290-3-3-.59(3), allows a program leading to an Alabama Professional Educator Certificate to be approved through the Continuous Improvement in Educator Preparation (CIEP) program review process; and

WHEREAS, Samford University submitted their programs for review in summer 2018 and were required to be resubmitted in December 2018; and

WHEREAS, the materials submitted December 2018 were reviewed and deemed either approved until June 30, 2027, Class B Programs: Elementary Education (K-6), English Language Arts (6-12), French (6-12 and P-12), Social Studies (6-12), German(6-12 and P-12), Mathematics (6-12), Choral Music (P-12), Instrumental Music (P-12), Spanish (6-12 and P-12); Alternative Class A Programs: Elementary Education (K-6), English Language Arts (6-12), Mathematics (6-12), Choral Music (P-12), Instrumental Music (P-12), Physical Education (P-12), Spanish (6-12 and P-12); Class A Programs: Elementary Education (K-6), Gifted (P-12), Instructional Leadership (P-12), Choral Music (P-12), Instrumental Music (P-12); Class AA Program: Instructional Leadership (P-12) or approved with conditions until January 31, 2025, Class B Program: Early Childhood Education (P-3); Alternative Class A Programs: Biology (6-12), Collaborative Special Education (6-12), General Science (6-12), Social Studies (6-12); and

WHEREAS, the outcome of Samford University's CAEP visit in November 2019 was positive and the result of the CAEP Accreditation review resulted in unit accreditation until June of 2027; and

WHEREAS, Samford University submitted revised CIEP documents in the summer 2023; and

WHEREAS, the CIEP program approval review constituted both a document submission and a formal visit to the institution; and

WHEREAS, Samford University documented compliance with all standards for the programs submitted; and

WHEREAS, Samford University submitted a progress report in September 2023 (i.e., revised course syllabi, matrix of program progression, evidence of faculty training in the Science of Reading, evidence of newly adopted textbooks, etc.) detailing their efforts toward meeting the recommendations provided by Barksdale Institute for Science of Literacy; and

WHEREAS, the Alabama literacy review team examined the evidence presented by Samford University and determined that significant progress has been made toward implementing the recommendations submitted by Barksdale; and

ADOPT AMENDED ALABAMA ADMINISTRATIVE CODE RULE, 290-3-3-.60, PERTAINING TO ALTERNATIVE TEACHER PREPARATION ORGANIZATIONS (ATPO)

EXECUTIVE (INCLUDES LEGAL AND PUBLIC INFORMATION)

Dr. Mackey stated that one item the Board has is a Decatur City resolution passed by the Decatur City Board of Education notifying the Department that they want to take advantage of certain stipulations in the Alabama Accountability Act Flexibility Section. The law states that the local school board can ask for an opportunity to waive certain laws. The waiver will require them to waive some state laws, but no federal law. There have been very few school systems that have requested this waiver. The waiver is the same as the resolution Baldwin County School Board passed earlier this year. Decatur City School System has set up a separate new comprehensive high school with a Career and Technical Education (CTE) focus. They wish to waive a state report card for three years. Dr. Mackey reminded the Board Members that Decatur City is only asking and will only receive the waiver on the state laws and no federal laws. Decatur City must continue all testing as the other schools perform. Dr. Mackey stated that the A through F Report Card is a state legislative law, which is not required under federal laws. The waiver will be granted only on the state law. The law requires that the local school board of education adopt a resolution, present it to the Alabama State Board of Education within a Alabama State Board of Education meeting. with no action required from the Alabama State Board of Education. Dr. Mackey stated that he visited the school earlier this year and it is a nice school. The model mirrors the one that Baldwin County School System implemented when they build a new high school. Decatur City built a new Austin High School and converted the old Austin High School into their new high school (Career Academies of Decatur). Decatur City School System will have three high schools instead of two. The students will take CTE courses with their regular core curriculum courses and that school gets on the report card.

STATE SUPERINTENDENT'S REPORT

Dr. Mackey acknowledged the following as the 2024 Blue Ribbon Schools: Carver School of Mathematics, Science, and Technology in the Dothan City School System, Principal Christopher Payne, and Superintendent Dr. Dennis Coe; Brookwood Forest Elementary School in the Mountain Brook City School System, Principal Nathan Pitner, and Superintendent Dr. Richard Barlow; EPIC Alternative Elementary School in the Birmingham City School System, Principal Aulandria Grace, and Superintendent Dr. Mark Sullivan; East Elementary School in the Cullman City School System, Principal Melanie Harris, and Superintendent Dr. Billy Barnette; Crestline Elementary School in the Hartselle City School System, Principal Karissa Lang (Terrel H. Bell Award Winner), and Superintendent Dr. Brian Clayton. For years, the national recognition was held in Washington during the same time as the Alabama State Board of Education's November meeting, but this year the national recognition was hosted last week. Dr. Mackey congratulated Mrs. Karissa Lang for earning the Terrel H. Bell Award and told her that she was the kind of principal that is wanted in all Alabama schools.

Dr. Mackey stated that this is a special time for reading. Many of you, your schools, especially the elementary schools participated in *Be a Champion and Read* contest. Dr. Mackey gave thanks to the Alabama Education Association (AEA) for their sponsorship. He said AEA has been sponsors for years. K-6 students are challenged to read six reading-level appropriate books to qualify for the Grand Prize: Iron Bowl tickets—one winner for each team—for the student and two quests. Each prize includes sideline passes and pre-game activities.

Dr. Mackey gave a big thank you to the schools of excellence, distinction, and Mary D. Boehm Schools of Achievement awards. To give some clarification, these are schools that are improving their outcome for advanced placement courses. Dr. Mackey stated that the Department worked with A+ College Ready on the selections. The schools of excellence are those who met their goals for the year. The schools of distinction met their goals for two years. Mary Boehm met their goals for four years.

Dr. Mackey stated that many principals and superintendents are in attendance today and he is looking forward to getting portraits as well as speaking with them. Dr. Mackey asked all honorees and representative to remain for portraits after the meeting. He gave a brief overview of the organizing of the portrait session.

There being no other business before the Board, on motion by Dr. Yvette Richardson and seconded by Mrs. Tracie West, Board Members voted unanimously to adjourn the meeting at 10:20 a.m. The next Alabama State Board of Education Meeting for Elementary and Secondary Education will be held on Thursday, January 9, 2025, at 10 a.m. in the Auditorium of the Gordon Persons Building followed by the Work Session.
