The principle objective of this course is to familiarize a Designated Person or other interested parties in the basics of asbestos, and to give an overview of the requirements for a local education agency under AHERA.



This class will cover common terms related to asbestos in schools, health effects of asbestos exposure, how to work safe around asbestos, response actions related to asbestos disturbance, regulatory requirements, responsibilities of an LEA, inspections, reinspections, and periodic surveillance, the parts and organization of a management plan, and how to update and maintain a management plan.
