## **EXECUTIVE (INCLUDES LEGAL AND PUBLIC INFORMATION)**

Dr. Mackey gave his semiannual report on Sumter County and Bessemer City School Systems. Both school systems are currently in state intervention. The report was very positive. Dr. Mackey stated that Sumter County School System is currently in its second year of state intervention and has submitted a budget in a timely manner this year. He said that his team assisted Sumter County School System with obtaining a Chief School Financial Officer. Dr. Mackey reminded the Board Members that prior to the state intervention, Sumter County School System's finances were in a disarray, and it did not have a Chief School Financial Officer. Sumter County School System's Chief School Financial Officer is working closely with Dr. Marcy Burroughs, Superintendent and Mr. John Heard, Chief Administrative Officer. Sumter County School System submitted its budget on time this year and rectified some of its personnel issues. Dr. Mackey stated that attracting personnel has been a challenge due to Sumter County being a rural area. He said most of the staff lives in Mississippi and Tuscaloosa. Sumter County School System had two schools to close. Dr. Mackey stated that the process of consolidating Sumter County into one campus is underway as construction is ongoing on the new elementary school that will be in the rear of the current high school. Dr. Tonya Chestnut joined Dr. Mackey in the fall of 2024 for the official groundbreaking ceremony of the new school. Dr. Mackey stated that working with Sumter County School System on Career and Technical Education (CTE) programs continues to be an issue. One reason is the CTE center is on the same campus as the old junior high school that has closed due to condemnation. Sumter County School System cannot afford to relocate the CTE center because all the finance was exhausted to build the new school. Dr. Mackey stated that a plan must be developed to accommodate the students who wants to enroll in the CTE courses. He said that his team is working with Sumter County School System on a solution. Dr. Mackey said they saw great academic growth last year in Sumter County School System. Dr. Mackey gave a big thank you to Mr. Heard for his help with the Sumter County School System.

Dr. Mackey stated that Bessemer City School System's intervention is only six months old. He said the Department will continue to work on the financial situation in the Bessemer City School System that is much better. Bessemer City School System submitted its budget in a timely manner this year and updated its salary schedule. Dr. Mackey stated that when the state intervened in August 2024, Bessemer City School System had many delayed repairs that caused severe deferred maintenance issues. The construction in the Bessemer City School System is underway. The Cognia review of Bessemer City School System was not great. Cognia outside review group from out of state stated that Bessemer City Board of Education continues to not be able to function on its own. Dr. Mackey said that was no surprise to him. He was asked if he thought that Bessemer City Board of Education was so bad that it deserved a two. Dr. Mackey stated that he would have rated them a one. He thought the outside reviewers gave Bessemer City Board of Education a lot of grace. Dr. Mackey stated that the Department will continue to work with Bessemer City Board of Education and ask them to go through further training this year.
