SUBJECT: 2024-2025 Alabama Association of Colleges for Teacher Education Surveys

The Alabama State Department of Education (ALSDE), Office of Teaching and Leading, is soliciting stakeholder feedback for the 2024-2025 Survey for Employers of New Teachers and its companion survey, the 2024-2025 Survey for New Teachers. Both surveys will be launched on Monday, March 3, 2025, and will run through Monday, March 31, 2025. The surveys were developed by the Alabama Association of Colleges for Teacher Education (ALACTE).

The purpose of the surveys is to provide feedback for the continuous improvement of educator preparation providers (EPPs) in Alabama. This data will help them make changes to ensure that they are preparing effective educators ready to perform essential functions on day one. Your input will help them determine their focus areas for improvement. The annual ALACTE survey results will be used to prepare the annual EPP Report Card. Results from the survey will be reported to the public in aggregate form only; however, more detailed information will also be provided to the EPPs. Individual teachers and employers will not be identified in the results. An Executive Summary of aggregated statewide results will be created and shared by the ALSDE.
