RE: Expansion of ACCESS Virtual Learning Career and Technical

Education Course Offerings

Alabama Connecting Classrooms, Educators & Students Statewide (ACCESS), the Alabama State Department of Education (ALSDE)-approved premier virtual learning program, is pleased to announce the expansion of career and technical education (CTE) course offerings for the 2025-2026 school year. These additions will provide students with expanded pathways and opportunities to achieve CTE completer status as indicated in Memorandum EY22-2065 and meet select criteria for the Alabama High School Diploma-Option B (AHSD-Option B) for the graduating classes of 2026 and 2027 and the select criteria for the Alabama High School Diploma-Option B for the graduating classes of 2028 and beyond.

Currently, ACCESS Virtual Learning offers one complete pathway in the Business Management and Administration cluster. ACCESS offers the complete Business Information Technology Program that includes the foundation courses of Business Software Applications I and Career Preparedness, as well as the concentrator courses of AP Computer Science A and Web Development.

For the 2025-2026 school year, ACCESS is scheduled to expand its CTE offerings by adding the programs listed on the following page.

Additionally, the ACCESS course development team is working to develop the Foundations in Education (2025), Safety and Health Regulations (2025), and Network Fundamentals or other Information Technology course (2026), which align with other CTE clusters and programs. These are in addition to the courses currently available on the <u>ACCESS course</u> list.

It is important to clarify that these are not new CTE pathways; rather, the delivery of the courses is new. School counselors and career coaches are encouraged to use the CTE
Program Guides along with the current ACCESS course listing to explore these newly delivered CTE pathway opportunities for students.

If any of the CTE programs listed above will be **new** to your district for the 2025-2026 school year, please complete the abbreviated new program application form linked here: Program Application form by May 1, 2025. This streamlined process is designed to maximize student options for meeting AHSD-Option B requirements. Once the form is submitted, please follow the standard process for officially declaring these programs at each school.
